#### Steps to find out your savings:

- Owner/Member makes a copy of the <u>Census Data Survey Form</u>. Fill out your copy with employee/their family details. Email the form to: <u>ECEAhealthplan@worldinsurance.com</u>.
- 2) Have your employees complete a Public Health Questionnaire (PHQ). This PHQ is encrypted, and HIPAA compliant, is English and will take about 10 minutes to complete. Every employee needs to complete this whether they will participate or not. Those not participating will indicate that they are not participating and sign so that they can not accuse you of not offering benefits in the future.
- 3) When all employee information has been submitted, the information will be reviewed by underwriting.
- 4) Once evaluated, a representative will reach out to you with pricing plans and all of your options. This takes about 3 business days. If you are NOT a member of ECEA, now is the time to join! Every licensed program has to have a membership to be able to purchase this health plan. You then select the plan that works for you. Health cards will be sent to you and the plan begins on 1/1/23.
